

VENDOR TERMS & CONDITIONS

Check in/Set-Up

Check in will start at 7:00 AM. The market will be open from 10:00AM-3:00PM

Check out time:

Vendors must stay until market is over at 3:00

- **Early departures will have to be approved by management. An example of an early departure would be a sell-out of items/goods.**

Rental Space

Vendors will get 1 10x10 space for \$25. Vendors may request an additional space(s) for a \$10 fee.

- If paying by check please make payable to Bethune Holdings LLC.
- If paying by credit card there will be a processing fee of 3%.
- If paying by cashapp[®] please make payment to \$tishtash004

Vendors will receive a receipt for all space payments.

Vendor spots will be designated by the Market Coordinator.

Vendor is responsible to supply their own set-up equipment: table, chairs, etc.

Texas Sales Tax

It is the vendors responsibility for state and federal tax fees.

Ground Rules:

This is a community market and we are looking for antiques, art, trendy clothing, décor, jewelry, organic items, farmers market, and collectibles.

- Vendor will review the vendor agreement
- Merchandise must be in good condition.
- Vendor is required to keep their area clean.
- A 48-hour notice of cancellation is required. Management reserves the right of refusal for future shows if there is no 48-hour notice.
- REFUNDS: Any cancellations prior to due date of booth fee will receive a full refund. Any cancellations made within 48 hours will not receive a refund. Any refund processed with a credit/debit card will not get a refund on the processing fee.
- If vendor has 2 no shows **without** a courtesy call and wishes to return for a third show there will be an additional deposit of \$25 to hold your spot. Your deposit will be given back to you the day of event.
- Management reserves the right to refuse the rental to any persons it deems necessary, especially for the sale of certain items. The sale of these items will not be permitted: Avon, Mary Kay, Scentsy, or any other multi-level marketing business model.

- Early departures will have to be approved by management. An example of an early departure would be a sell-out of items/goods.
- Beeville Saturday Market will be held rain or shine, cold or hot. **We will not refund for cancellations within 48 hours due to weather.** If inclement weather is hazardous and Beeville Saturday Market decides to cancel, then all vendors will receive a refund of their registration fee.
- The acceptance and space rental on property at Hattie and Hazel's constitutes a complete release by Vendor of Owner's Liability from all claims for injury and damage to persons and property arising out of, or in any way related to, Vendor's use of the premises, injuries caused by others or injury to persons entering these premises or damage or loss due to fire, theft, breakage, or collision, or articles left in dealers vehicles or on the premises including all costs, expenses, and attorney's fees incurred by Owner in connection with any such claims.

PRODUCT LIMITS

- **No fireworks/explosives of any kind shall not be sold by anyone**
- **There are no sales or giveaways of animals in any form at Saturday Market**
- **We reserve the right to remove any item judged unacceptable. We reserve the right to limit the number of spaces of the same product.**
- **Direct Sales Companies or Multi-Level Marketing business models will not be allowed at Saturday Market**

CLEAN UP

It is your responsibility to clean up your area before leaving. There are trash barrels provided throughout the market area. **You may not dump ice, grease, or anything on the ground.**

RESTROOM FACILITIES

There are Portable toilets available located behind Hattie and Hazel's.

All vendor spaces are located outdoors and most spaces do not have shade. Please plan accordingly and supply your own tent, tables and chairs. Bring weights for your canopy if needed, especially on windy days.

No vehicles are permitted inside the barricaded area once the barricades are in place. Do NOT remove the barricades, this may result in a vendor not being able to return to market. This is a matter of public safety.
